# **Election Summary**

Writs of election for the general election on October 19, 1992 were issued to the returning officers by the Commissioner of the Yukon, Ken McKinnon on September 18, 1992. In June of 1992, the *Electoral District Boundaries Act* was passed by the Yukon Legislative Assembly and as a result there was a change in the number of electoral districts from 16 to 17 electoral districts at this election.

Nomination day was September 28, 1992 and 52 candidates were nominated. The number of candidates endorsed by the registered political parties was as follows:

Independent Alliance	0
Yukon Party	14
Yukon Liberal Party	14
Yukon New Democratic Party	17

In addition, there were seven independent candidates nominated. There were five electoral districts with four candidates each, four electoral districts with two candidates and the remaining electoral districts each had three candidates.

Advance polls were held in every electoral district on Sunday, October 11 and Monday, October 12, 1992. Six hundred and twenty electors voted before polling day.

The *Elections Act* was amended before the general election to provide for electors who were housebound, who were attending a Yukon education institution not situated in their electoral districts, or who were working away from their resident polling division and would not be able to vote in person. There were 94 electors who applied to vote by special ballot.

Another amendment allowed 312 qualified voters who were either not enumerated or unable to have their names added during revision hearings to appear in person at returning offices on October 16, 1992, three days before polling day, to be added to the lists of electors in order to vote.


In total, 13,104 electors voted. This number included remand prisoners, hospital patients and other voters who marked mail-in ballots and 385 electors who were outside the Yukon on polling day and entitled to vote by proxy.

One judicial recount was required for the Electoral District of Whitehorse Centre. It took place in the Supreme Court of the Yukon on October 23, 1992 and resulted in no change to the outcome of the election.

The election in Whitehorse Centre was declared on October 23, 1992 and the results in the remaining 16 electoral districts were declared on November 2, 1992.
