ADDENDUM TO THE REPORT OF THE CHIEF ELECTORAL OFFICER ON ELECTION FINANCING AND POLITICAL CONTRIBUTIONS 2011

This report amends the *Report of the Chief Electoral Officer of Yukon on Election Financing and Political contributions 2011* as follows:

A. Appendix II: Candidates Election Financing Returns, 2011 General Election

Two candidates were issued a *Certificate and Compliance Order* on March 26, 2012 for failing to file election financing returns as required by the *Elections Act*. The Act states:

“Enforcement

399.1.(1) The chief electoral officer may issue directions to officials or official agents to enforce the requirements of this Part.

(2) A compliance order pursuant to Part 4 may be issued to a registered political party or a candidate who fails to fulfill the requirements of this Part.

“Compliance order

352.(1) If the chief electoral officer believes that any person or registered political party is contravening the provisions of this Act, the chief electoral officer may issue a certificate addressed to the person or registered political party setting out the particulars of the contravention and ordering the person or registered political party to cease contravening this Act.

(2) A certificate under subsection (1) may order a person or registered political party to cease doing any act that contravenes this Act, or to do any act that this Act requires the person or registered political party to do.

(3) The chief electoral officer may file a certificate issued under subsection (1) in the office of the clerk of the Supreme Court.

(4) A certificate filed in accordance with this section shall be deemed to be a judgment of the Supreme Court in favour of the chief electoral officer and may be enforced, on application to the court by the chief electoral officer, as a judgment of the court.

(5) A certificate under subsection (1) may be served by delivering it to any address of the person or registered political party provided to an election officer under this Act.

Both candidates have now filed with the chief electoral officer.
