COMPLETING AND FILING A NOMINATION PAPER

ELIGIBILITY

Candidate and elector eligibility are the same. A person may file a Nomination Paper only if they are an eligible elector. To be eligible to be a candidate, nominate a candidate or vote in a school council election, as of Polling Day a candidate or an elector must:

- be a Canadian citizen; and
- be at least 18 years old, and
- live in the attendance area for at least three months, and/or be a parent of a child attending a school in the attendance area.
- schools established on the basis of religion have additional eligibility requirements (see Candidate Guide)

COMPLETING THE NOMINATION FORM

A sample of a Nomination Paper is attached to help you complete your Nomination Paper to ensure that it is accepted by the Returning Officer when you file. You should read these instructions before you fill in the Nomination Paper.

INSTRUCTIONS

- 1. Print name of school.
- 2. Print full name last, middle and first name.
- 3. Print the name to be used on public notices; this should be the name you use in the community or are commonly known by.
- 4. Print your physical address.
- 5. Print your mailing address (if different).
- 6. Include your contact information for use by the Returning Officer and Elections Yukon. Indicate which should be used as your primary contact.
- 7. Print your name and sign in the presence of the RO, a Justice of the Peace, a Notary Public or a Peace Officer, to confirm your eligibility and your consent to be nominated as a candidate.
- 8. To be signed and dated by the RO, Justice of the Peace, Notary Public or Peace Officer.
- 9. For Returning Officer use. The time your nomination package is received will be recorded to confirm it is within prescribed deadlines. It will also note if a Statement of Ineligibility is filed and, after review, confirm your approval as a candidate.

INSTRUCTIONS (Cont'd)

- 10. Print name of school.
- 11. Print your name as the candidate.
- 12. Print the name and physical residential address of each elector making a nomination. Electors must be qualified to vote in the School Council election to nominate a candidate. Electors to sign.
- 13. If you, as candidate, were present when your Nomination Paper was signed by the nominating electors, you may be the witness to their signatures. You must sign the declaration in the presence of the Returning Officer at the time of filing. Or in the presence of another authorized person (Notary Public, Justice of the Peace, or Peace Officer).
 - If you were not present, the person who witnessed the signatures must sign in this section in the presence of one of the authorized persons named.
- 14. This section to be completed and signed by the authorized person (Returning Officer, Notary Public, Justice of the Peace, or Peace Officer) who takes the declaration of the witness.
